Fundraiser Participation Consent

- Each student shall be required to have a signed parent/legal guardian permission slip PRIOR to being allowed to participate in fundraising activities.
- The school will explain, to the extent possible, how the money earned will be spent (i.e. computers, supplies, etc.)
- There shall be no door-to-door sales without adult supervision.
- There shall be no solicitation on private property (i.e. malls, grocery stores, shopping centers) without written permission from the property owner/manager and without adult supervision.
- Students shall be prohibited from direct solicitation, or the holding of directional signs, in or on public thoroughfares.
